# SPRING 2024 FLIGHT LAB DEADLINES

---

## **January 7 – Spring 2024 Registration and Retention Deadline**

- All remaining requirements and documents must be submitted to [FlightLab@mtsu.edu](mailto:FlightLab@mtsu.edu) in order to retain flight lab by the end of this day or student will lose lab.
- All students are required to obtain any prerequisite pilot certificate or rating for their respective flight lab by the end of this day or they will lose their lab.
- Students must also be registered for the lab and all co-requisite courses by the end of this day or they will lose their lab slot.
- International students in labs that require TSA approval must be granted "Final Approval" from the Flight Training Security Program (FTSP) by the end of this day or they will lose their lab slot.

## **January 12 – Flight Account Fully Funded**

- All students must have all flight lab fees deposited into their flight account by 4:30pm on this day or have received a waiver from [FlightLab@mtsu.edu](mailto:FlightLab@mtsu.edu).

## **January 16 – First Day of Spring 2024 Flight Labs**

- All Fall 2023 incomplete students must resume training as of this date. Students will be held to the spring attendance policy and will be required to meet with their instructor accordingly until FAA checkride is complete.

## **January 17 –Spring Semester Launch**

- All students and instructors will be required to attend the Spring Semester Launch. Please do not skip any class for this. The meeting will be held in the Student Union Grand Ballroom from 6pm to 8pm.

## **January 23 – First Week Requirements Deadline**

- All requirements listed in the *Flight Lab Guide* must be met by the end of this day. This includes presenting TSA documentation to your flight instructor, completing first day paperwork, and purchasing your required materials.

## **March 12 – Mid-Semester Student Briefing**

- All students will be required to attend the Mid-Semester Student Briefing. Please do not skip any class for this. The meeting time and location to be TBD.

## **April 15 – Summer 2024 Flight Lab Request Forms Due**

- Submit your form electronically no later than this date. Request forms can be accessed via a link on the MTSU Aerospace website.
- All files must be submitted in JPEG or PDF format.
- Be sure to follow all instructions carefully; Late applications may be considered after all eligible and on time submissions.
- Students will receive an automated response verifying receipt but are strongly encouraged to save a copy for future reference.

## **April 22 – Summer 2024 Flight Labs Awards Announced**

- Students will be notified by email of their lab award status
- Read carefully and complete any necessary steps before the deadlines noted in the award email. Not completing the necessary steps outlined in the award email may result in your awarded lab being rescinded.

## **April 24 – Last Day of Spring 2024 Flight Labs**

- If you are a prior semester incomplete student, you must have completed your checkride by this date or you will receive an "F" for the course.
- Checkrides may not be scheduled for prior incomplete students after this date.

## **May 5 – Spring 2024 Grades Due**

- We will begin evaluating your GPA to see if you qualify for a Summer 2024 flight lab

## **May 12 – Summer 2024 Registration and Retention Deadline**

- All remaining requirements and documents must be submitted to [FlightLab@mtsu.edu](mailto:FlightLab@mtsu.edu) in order to retain flight lab by the end of this day or they will lose their lab.
- All students are required to obtain any prerequisite pilot certificate or rating for their respective flight lab by the end of this day or they will lose their lab.

- International students in labs that require TSA approval must be granted "Final Approval" from the Flight Training Security Program (FTSP) by the end of this day or they will lose their lab slot.

## **May 20 – First Day of Summer 2024 Flight Labs**

- All Spring 2024 incomplete students who resume training for the summer semester will be held to the attendance policy and will be required to meet with their instructor accordingly until FAA checkride is complete.

## **May 21 –Summer Semester Launch**

- All students and instructors will be required to attend the Summer Semester Launch. Please do not skip any class for this. The meeting time and location to be TBD.
