3 Year Degree:

Robert Summers, Vice Provost International Education, presented Proposed that an International Student with a foreign Bachelors Degree that is a 3 year degree, should be reviewed by the Program Director on a case-by-case basis rather than rejecting the student's application for admission.

Thoughts of the Committee:

International Education is to draft the policy and present to Policy Committee to review

Exceptions for Grad/Faculty:

Lisa Pruitt, History, presented Proposed to allow qualified candidate, who may not have tenure, to direct a thesis

-Students applying for degrees in historic preservation- only person with tenure who can direct a thesis in historic preservation is planning to retire spring 2026, therefore will not be taking new PHD applicants. Another person is qualified to teach but is eligible for adjunct not tenure. Can certain research faculty who qualify for full faculty status or adjunct direct a thesis/dissertation?

Thoughts of the Committee:

Committee agrees this should be done on a case-by-case basis as there are many factors to be considered and this seems to be a very narrow situation. Dr. McCormack and Provost will work together to look at individual situations, unless it becomes a trend, a policy will not be created.
