Strengths

- has a **comprehensive** and diverse area of work and has great experience with a diverse population of students

Weaknesses

- no apparent experience with directing a graduate program (aside from being a department chair)

2 – Beach

Strengths

- decades of experience within the field
- administrative experience as co-director of OU Center for Peace and Development
- a record of consulting work, which seems relevant to the work of a program reviewer
- lengthy graduate teaching record
- Extensive experience in teaching and mentoring
- has a good international collaboration with other researchers of the educational field.

Weaknesses

- Does not seem as experienced and culturally diverse in terms of different areas when compared to Dr. Flint

3 – Burke

Strengths

- impressive record of publication and service within the discipline
- current graduate coordinator (since 2018)
- teaches in PhD program
- Diverse Area of interest, especially Queer and Gender studies

Weaknesses

- not as experienced as Flint or Beach
- has not chaired a department
- Does not seem as experienced and culturally diverse when compared to Dr. Flint
