# GRADUATE COUNCIL MINUTES February 27, 2008

#### II. Announcements

#### A. Dr. Philip Phillips, Chair

Dr. Phillips welcomed Dr. Ron Ferrara from the Aerospace department who has replaced Dr. Wayne Dornan on the Council. Dr. Ferrara was appointed to the Graduate Program Review committee.

#### B. Dr. Peter Cunningham, Interim Associate Dean, College of Graduate Studies

Dr. Cunningham noted that the 2007-2008 Graduate Catalog is now available. The new two-year (2008-2010) Graduate Catalog will be available two weeks prior to the beginning of the Fall 2008 semester. All curriculum changes through April 30, 2008 will be included in the 2008-2010 Graduate Catalog.

# B. Student Affairs and Travel Dr. Kevin James, Chair

• Dr. James reported the Graduate Program Enhancement Budget was depleted in mid-February. The Dean of Graduate Studies has approved an additional \$10,000 temporary budget revision to accommodate faculty and student travel demands for the remainder of the semester.

#### C. Policies and Procedures Dr. Jane Williams, Chair

This statement is for clarification purposes only since this policy is currently in effect. The statement reads: *Graduate faculty membership is not required to teach dual-listed (4000/5000) courses.*

# D. Graduate Program Review Dr. Teresa Davis, Chair

• Dr. Davis distributed schedules for the Graduate Program Reviews. The Exercise Science Review was completed on February 22<sup>nd</sup>. Dr. Eller noted that during the Exercise Science Exit Interview the issue of faculty supervising theses during the summer without compensation came up. Dr. Phillips advised drafting a proposal on the subject to present to the Provost.

#### E. Catalog Committee Dr. Jackie Eller, Chair

• Dr. Eller noted the need to begin reviewing the 2007-08 Graduate Catalog immediately since there is a May 19<sup>th</sup> deadline. Dr. Eller stated the Committee has prepared survey questions regarding such items as graduate catalog appearance, usefulness, and policies. There will also be a vote on whether the Graduate Catalog should continue to be available in hard copy only, electronically or both. Surveys will be sent to department chairs, graduate directors and graduate faculty. Any additional survey questions can be sent to Dr. Eller as soon as possible.
