A. Dr. Craig Rice, Chair

Dr. Rice opened the meeting.

B. Dr. Michael Allen, Dean, College of Graduate Studies

Dr. Allen noted that the budget for the Faculty Research and Creative Activity Committee (FRCAC) has been reduced significantly due to budget cuts. Previously the annual budget was \$563K. The annual budget is now \$113K.

Electronic submission of Thesis/Dissertation:

Dr. Amy Sayward reported that the College of Graduate Studies plans to begin having students submit their theses and dissertations electronically through ProQuest UMI Dissertation Publishing. Currently, for paper submissions, ProQuest UMI charges \$65 for publishing doctoral dissertations and \$55 for publishing masters theses. They charge no fees for electronic submissions. In January, staff from ProQuest UMI will come to our campus to ensure a smooth transition into the electronic submission process. There will be a soft rollout of the electronic submission process in the summer of 2012. The full rollout will be in the fall of 2012.

<u>Other</u>

Effective Spring 2012, institute a cognate option (6-9 credit hours) for English Ph.D. students.

The cognate option in the Ph.D. degree plan allows doctoral students to take graduate-level courses (6000 and 7000 level) in other disciplines related to their areas of concentration or professional goals that would apply as electives toward the degree in

English. The cognate option is limited to a minimum of six hours and a maximum of nine hours.

Other

Effective Spring 2012, revise the M.A. requirements concerned with selecting a minor to read: The Thesis Option requires 9-12 semester hours in the minor, plus a minimum of either 21 or 18 hours of English to attain the requisite minimum of 30 earned graduate hours.

Effective Spring 2012, revise the M.A. requirements concerned with selecting a minor to read: The Nonthesis Option requires 9-12 semester hours in the minor, plus a minimum of either 27 or 24 hours of English to attain the requisite minimum of 36 earned graduate hours.
