The Graduate Faculty and Curriculum Review Committee is tasked with the review of both the graduate curriculum changes and applications for graduate faculty membership. Dr. Handy also charged this committee with proposing solutions to stretch the travel budget so that funds will be available for those presenting in the spring semesters. The Graduate Program Review Committee will be responsible for assessing and ranking the graduate program external reviewers before presenting them to the full Council. There will be four graduate program reviews this academic year. They include:
