- 1) Not completing the prerequisite course(s) for the lab you have requested, as required by the MTSU catalog.
- 2) Not completing the prerequisite flight lab checkride seven days prior to the start of the summer semester.
- 3) Not having the entire flight lab fee deposited into your flight account by the last day of the first week of the summer semester. Only written proof from an official source of funding (financial aid, bank, mortgage company, Veteran's Administration, etc.) will be acceptable as a promissory. You must have a minimum amount of \$500 in your flight account by the end of the first day of the summer semester to cover the first week's ground expenses. **APPLY FOR LOANS EARLY!** (See the "Additional Information Packet.")
- 4) Not having the required Transportation Security Administration documents in your possession on the first day of the flight lab. (See the "Additional Information Packet.")
- 5) Not having a current second class medical certificate in your possession on the first day of the flight lab. (See the "Additional Information Packet.")
- 6) Not having a current and valid student-pilot certificate, if applicable, in your possession on the first day of the flight lab. (See the "Additional Information Packet.")
