Agenda

1. Roll Call: President Mary Martin called the meeting to order at 3:32 p.m. and acknowledged the presence of a quorum.

2. Draft minutes for the September 12 and October 5 meetings were mistakenly not distributed. They will be distributed this week and presented for approval at the November meeting.

3. Dr. Martin introduced Tyler Babb, newly-elected Senator representing the Department of Aerospace.

5. Proposed Resolution from TUFS: At the September 2016 meeting, Tennessee University Faculty Senates (TUFS), composed of the six TBR universities and four UT campuses, proposed a resolution that condemns recent actions by Long Island University (LIU) administration in response to a contract dispute with faculty. If six member senates vote to approve the resolution, it will be adopted by TUFS. No amendments or changes can be proposed. Proposed resolution states:

Proposed TUFS LIU Resolution

WHEREAS the administration of Long Island University (LIU), during a contract dispute, took the unprecedented action of locking out all faculty members, barring them from access to campus, email, and health care benefits, and,

WHEREAS for the first week of classes, the administration of LIU staffed classes with administrators and other replacements unqualified to instruct the courses they were assigned.

SUCH ACTIONS show disrespect for the faculty, disregard for the quality of instruction in classes, and disservice to their student body.

WHEREAS the lockout ended only after students protested these actions, and

WHEREAS these actions by the LIU administration suggest a total disregard for the principle of shared governance traditional in American universities, and

WHEREAS the American Association of University Professors, the American Library Association-Allied

Professional Association, and faculty of other universities have condemned this action,

THERFORE BE IT RESOLVED that the Tennessee University Faculty Senates (TUFS) also condemn the actions taken by the LIU administration in this matter.

BE IT FINALLY RESOLVED That TUFS communicate this resolution to the President of LIU and the LIU Faculty Federation.

Discussion: Dr. Martin briefly explained the background behind the proposed resolution. Vote: The resolution was approved by voice vote.

6. Draft of *Vision and Direction Document* (working group comments) from August 2016 Faculty Senate Retreat

Dr. Martin distributed a draft of the document compiling comments from the working group discussions held during the August 2016 retreat. She plans to distribute the final document to President McPhee, the President's cabinet, deans, and chairs.

Dr. Martin briefly discussed faculty workload and the workload form, topics included in the retreat document and currently receiving attention from various groups on campus. In short, forms completed as directed present an inequitable view of individuals' workload. Further, the concepts of workload and teaching load are not clearly defined and thus often confused. To aid discussions, Dr. Martin has asked for copies of workload forms and information about teaching workload and grant production from TUFS faculty senate presidents.

The vision document also includes screen-shots of a questionnaire about faculty workload recently distributed to self-identified peer institutions by the University of Northern Colorado. The questions and possible responses can provide insights useful to discussions at MTSU. Of particular note: Possible responses to the question about "teaching load during annual contract term" include nothing heavier than a 3/3 load (i.e., 3 classes in Fall semester and 3 classes in Spring semester).

7. Training in Shared Governance for MTSU Board: Dr. Martin asked for suggestions to be made to administration about training for the MTSU board members, including topics, training format, and possible individuals to provide training. The ensuing discussion centered on the need for faculty to be an involved partner with administration and the board in shared governance and the need to inform board members about the true nature of faculty work.

Michael Rice moved that "the faculty senate be integrally involved in establishing the protocols for the new board and training for the new board." Justin Gardner seconded the motion, which passed by unanimous voice vote.

Dr. Martin distributed a list of proposed members for the state university boards (see attachment).

8. Recent emails from animal rights group: Dr. Martin mentioned that several administrators and faculty have received emails from an animal rights group that is questioning Aramark's connection to inhumane treatment of animals. President McPhee has indicated this is an issue between Aramark, its suppliers, and the rights group, and that the university is not involved.

9. Dr. Martin plans to eat lunch in the JUB dining room on Tuesdays in order to provide a forum for conversation.

10. Dr. Martin raised the question of electing a regular member of the faculty senate to act as representative for full-time temporary (FTT) employees, Graduate Teaching Assistants, etc. An alternative proposal is to appoint an ombudsperson to act as mediator and information provider for these groups. A course release for a FTT employee to act in this capacity would require 150 hours of work. Alfred Lutz pointed out that the Faculty Senate voted against establishing an ombudsperson position in 2006. Discussion about possible solutions included the following ideas:

- Create a process for FTTs to elect their own senator, even if that senator is not an FTT.
- Encourage existing senators to reach out to FTTs in their department to tell them know they have a senator who can represent their interests.
- Encourage FTT's to coordinate communication among each other.

Additional discussion involved mention of contractual prohibition for FTTs to perform activities outside of teaching, such as serving on committees. One example of instances where FTT would benefit from an advocate is the case where FTTs may possibly be let go on the basis of current student evaluations only—the evaluation does not consider past evaluations or the entire record of an individual's work. This discussion was prematurely abandoned by Dr. McPhee's scheduled arrival.

11. President McPhee addressed the senate from 4:47 p.m. to 5:45 p.m. He briefly introduced the background, MTSU involvement and term length of the proposed MTSU board members (see attached list). Dr. McPhee expressed pleasure at the comprehensive, efficient process the Faculty Senate developed to elect the board's faculty representative, Tony Johnston. Dr. Johnston, who will fill a two-year term, will represent all MTSU employees in his role as board member. Dr. McPhee feels that Governor Haslam did a "fabulous job" selecting board members for MTSU. Haslam's stated goals were to select individuals who:

- demonstrate a deep passion for the institution,
- are focused on the institution and understand its needs,
- understand the role of a governing board and the board's role in policy direction as opposed to operational direction,
- have made a difference for the resources of the university, and who can open doors to help the university accomplish its mission.

Each of the proposed MTSU board members has a history of support and involvement at MTSU, and Dr. McPhee has an existing personal relationship with seven of the eight individuals.

At their first meeting, the board will elect a chair and will develop a procedure for selecting the MTSU student member of the board. Although there will be costs associated with supporting the board, MTSU is trying to avoid hiring new staff for this purpose. Heidi Zimmerman, MTSU Counsel, will be the board secretary, and Kim Edgar will be the board's chief of staff. MTSU will make space for the board offices in the Cope Administration Building. The board has fiduciary responsibility for MTSU—overseeing the budget, hiring the president, and making overall decisions regarding tuition and fees (THEC sets maximum limits for undergraduate tuition). One of President McPhee's priorities is to educate the board members about the Tennessee financial and political climate for public higher education.

Communication with the MTSU Board: Dr. McPhee's primary role is to work with the board in implementing policy and to manage the operation of the university while the board oversees and sets policy. It will not be efficient for staff or faculty to have contact with board members about day-to-day matters. The board will establish committees to help in its work, committees for areas such as budget and finance, personnel, academic programs, etc., and it is possible that faculty members could serve as non-voting members of a committee. Dr. McPhee will ensure faculty and staff have appropriate opportunities to meet the board members in a social setting.
