VI. New Business

a. Dr. Scott Handy, Interim Associate Dean, College of Graduate Studies

English Language Proficiency expansion. In an effort to update and make the graduate level options more consistent with the undergraduate options for international students to demonstrate English language proficiency before TBR effectively ceases business and we have to wait for at least an additional year, the proposal to modify the English language proficiency standards at the Graduate level was brought directly to Graduate Council (see attached). There was discussion that these standards are already not adequate for some programs, and it was pointed out that, while we have been stopped by the President from raising standards across the board, there is still the option for individual programs to raise their standards and that this change certainly has the support of the College of Graduate Studies. It was also mentioned that exceptions to the English language standards are not being considered at present in an effort to at least enforce our current (low) standards. This remains a topic of importance to Graduate Studies and across campus. It was also discussed that enforcement of the higher GTA standards should be considered – particularly if there is a way to monitor this readily at the College of Graduate Studies level. This idea will be investigated, but it may have to be a program level point of emphasis.

b. Dr. Eller, Interim Dean, College of Graduate Studies

In addition to the GA proposal that was mentioned last month and has been submitted to the Provost, a more targeted proposal from Aviation has also been submitted. This proposal calls for making available 5 graduate scholarships to Flight Instructors in the Pro-pilot undergraduate program that will cover the tuition costs for 6 hours per semester for one year to get the students started in the MS program, while still allowing them to serve as flight instructors and obtain the flight hours necessary for certification.

With this start, and the fact that the Aviation courses are available on-line, it is anticipated that the students will continue on to complete their MS degree as revenue producing students. Even assuming some attrition, it is anticipated that the program would be revenue producing in year 3 and will certainly serve to keep us competitive with Embry-Riddle, Delta State, and Purdue University (all of which have similar programs for their Pro-pilot flight instructors).

Proposed Graduate Catalog Statement

Proof of English Proficiency

International students who will be attending the University on a visa and who are not native speakers of English or graduates of a United States undergraduate or graduate institution must submit a demonstration of English language proficiency. This can be accomplished in a number of different fashions:

1. Test of English as a Foreign Language (TOEFL) score (minimum score of 525 paper-based or 71 Internet-based),
2. International English Language Testing System (IELTS) score (minimum score of 6.5),
3. Michigan English Language Assessment Battery (MELAB) test score (minimum score of 74),
4. PTE Academic (minimum score of 55),
5. International Test of English Proficiency (iTEP) score (minimum score of 4.5),
6. E.L.S. instruction (completion of level 112), or
7. International English Institute (IEI) instruction (completion of level 6 in all course areas offered).

Note that certain programs may require higher standards, so please consult the program coordinator for more information.
