#### **REINSTATEMENT OF DACA**

In a memorandum addressed to the Attorney General and the Secretary of Homeland Security (Homeland Security), the Biden-Harris Administration announced the reinstatement of protections under the Deferred Action for Childhood Arrivals (DACA). The memorandum directs Homeland Security to preserve and fortify DACA actions ....(cont. on page 2)

#### OCR Video Release on Title VI

The Department of Education's Office of Civil Rights (OCR) released two new videos on OCR's application and interpretation of Title VI of the Civil Rights Act of 1964 (Title VI). Title VI prohibits discrimination based on race, color, or national origin. Among other regulations, MTSU must comply with Title VI as a public institution that receives federal financial assistance under Title VI for its academic programs and activities. Additional information on Title VI and Title VI training for University employees is available from the University's Office of Institutional Equity and Compliance.

OCR's new Title VI videos for 2021 include the following:

- Racially Exclusive Practices and Title VI The video provides examples of how racially exclusive policies and practices may violate
   Title VI and may not satisfy the strict scrutiny analysis required. The video also discusses Title VI implications in grading policies and assignments, as well as in teaching anti-racism based on racial stereotypes and classifications.

- <u>Use of Race in Admissions and Programs</u> The video summarizes OCR's previously issued guidance regarding how colleges and universities can comply with anti-discrimination laws and regulations relative to the use of race in postsecondary admissions and programs. consistent with applicable law. The memorandum follows a December 2020 District Court Order directing the U.S. Citizenship and Immigration Services (USCIS) to begin accepting initial DACA applications, DACA renewal requests, and applications for advance parole documents based on the provisions of the prior DACA policy of September 5, 2017. USCIS additionally has been directed to extend one-year employment authorization documents under DACA to two years for individuals who were issued documentation on or after July 28, 2020.

#### ANNUAL RISK ASSESSMENTS


Annual Risk Assessments (RAs) are in process for the Divisions of Academic Affairs and Business and Finance. As in past years, a University-wide Risk Assessment also will be completed and will be presented for review by senior executive administrators, as well as by the MTSU Board of Trustees.

MTSU conducts annual risk assessments of its operational and academic divisions as part of its compliance and enterprise risk management (ERM) program. The performance and completion of annual risk assessments also aligns with the internal control best practices outlined by the Government Accountability Office, the Committee of Sponsoring Organizations of the Treadway Commission's ERM framework, and the State of Tennessee's Finance and Administration Division.

# NEW VIDEOS: FERPA COMPLAINT PROCESS – FEDERAL STUDENT PRIVACY POLICY OFFICE

The federal Student Privacy Policy Office (SPPO) developed new videos about the Family Educational Rights and Privacy Act (FERPA) complaint process. The videos provide information on: who may file a complaint; common reasons complaints are filed; and the next steps taken by the SPPO whenever a complaint is filed with their office.

The SPPO also redesigned its complaint page to add FERPA complaint forms. Eight, full-color FERPA flyers are also available from the SPPO for free download for posting in classrooms, faculty offices, staff offices, and other areas of the University. The FERPA flyers from the SPPO are available <a href="here">here</a>.

Students have the right to file a complaint with the SPPO if they believe their FERPA rights have been violated. MTSU students may also contact any of the following offices if they have concerns about their FERPA rights:

- MT One Stop/Office of Registrar
- ITD Security

Policy 90, Athletics Integrity and Conduct of Athletics Staff, has been revised to provide clarity that investigation matters covered by MTSU's discrimination-based policies (i.e. Policies 26, 27, and 29), as well as matters covered by NCAA/Conference USA rules, are not subject to review under Policy 90's conflict resolution process.

# OCR Issues Technical Assistance Regarding Title IX Regulations

On January 15, 2021, the OCR issued a Technical Assistance document to help colleges and universities meet their obligations under Title IX. The Technical Assistance consists of a series of **Questions and Answers** in two parts on the OCR's Policy Guidance Portal. The Technical Assistance documents cover guidance on some of the following topics:

- Applicability of Prior OCR Guidance and how the OCR reconciles changes in the Title IX regulations.
- 2. Information about the deliberate indifference standard regarding sexual harassment cases.
- 3. Investigation of complaints under Title IX at off-campus locations.
- 4. Notification and role of parents regarding the filing of complaints.
- 5. Applicability of Title IX requirements among employees within an organization.
- 6. Whether or not Title IX proceedings and the issuance of sanctions need to be handled in a single process, or if sanction and discipline proceedings can be handled in proceedings outside of 34 C.F.R. § 106.45.
- 7. Record keeping requirements following the seven year retention period for Title IX cases.
- 8. Applicability of FERPA and confidentiality under Title IX.
- 9. Clery Act geography.

# Regulatory Minute: What's Going On?

#### 1. Letter of Support for International Students and Foreign Scholars by the AACU

The Association of American Colleges and Universities (AACU), along with other higher education associations, provided three letters to the U.S. Department of State and Homeland Security recommending specific actions to facilitate the enrollment of international students and foreign scholars.

#### 2. OCR Issues Q&A Regarding Title IX and Single Sex Scholarships, Clubs, and other Programs

In addition to its other guidance issued in January 2021, OCR provided a series of questions and answers regarding how it evaluates Single Sex Scholarships, courses, clubs, extracurricular activities, school facilities, and other programs that impose certain preferences or restrictions based on sex. The guidance document is meant to assist and support colleges and universities with meeting the regulatory obligations under Title IX. # 3. Executive Order Preventing and Combating Discrimination on the Basis of Gender Identity or Sexual Orientation

A federal Executive Order under the Biden-Harris administration extends federal nondiscrimination protections to members of the LGBTQ community, aligning with the Supreme Court decision in Bostock v. Clayton County, Georgia opinion. Nondiscrimination protections under the Executive Order include sexual orientation, gender identity, and gender expression.
