The scope of this project consist of adding streambank stabilization to the outlet of stormwater pipes by using rip rap (rock), vegetative cover and grass seed to keep the sediment from eroding into the drainage ditch or stream. This project will help keep our streams clean and free of sediment and pollution runoff.

We not only protect our local streams but the campus infrastructure will function better.
