The scope of this project consist of replacing manhole lids on campus to help reduce stormwater infiltration into the sanitary sewer system. The project will replace stormwater sewer lids and sanitary sewer lids with a composite polymer material lid. The original lids will be recycled.

The benefit of adding this project of manhole lid replacement will keep rain water from entering the sanitary sewer system. This accomplishes several results such as less rain water entering the sanitary system which then causes less sewer overflows downstream and less flow to the waste water treatment plant (WWTP). By reducing these overflows, we help keep ecoli and bacteria out of our streams and rivers. By lessening the flow to the WWTP we reduce the amount of energy it takes to process clean water that ends up in our river.
