

GRADUATE COUNCIL MINUTES

JULY 26, 2007

The Graduate Council met at 1:00 p.m. in the Garden Level Conference Room of the Sam Ingram Building. Philip Phillips presided as Chair.

II. Announcements

A. Dr. Philip Phillips, Chair

Dr. Phillips thanked Dr. Allen and the Graduate College for treating the Council to lunch during this meeting.

B. Dr. Michael Allen, Vice Provost for Research & Dean, College of Graduate Studies

Dr. Allen reported that there were three strong research oriented degrees asked for originally. They included new PhD programs for Computational Sciences, Math and Science Education, and Integrative Life Sciences. The Computational Sciences and Math and Science Education proposals have been sent forward for President McPhee's signature. We expect soon they will go before the board for approval.

Dr. Allen stated that the Integrative Life Sciences program will need to be clearly defined in its purposes for MTSU before moving forward.

C. Dr. Pamela Knox, Associate Dean, College of Graduate Studies

Dr. Knox offered many thanks to the committee for their wonderful service during the past year. She suggested that the Catalog Committee begin working on the new catalog two years in advance instead of one. Two years allows more time and attention for working with departments in updating the information.

III. Approval of minutes from last meeting—April 26, 2007

A motion was made to accept the minutes of the April 26, 2007 meeting with an amendment to the New Business to include Philip Phillips to serve on the Suspension & Appeals Committee on May 22, 2007. The motion was seconded and passed.

IV. Sub-Committee Reports

A. Graduate Faculty and Curriculum Review

- Consent Calendar attached --- Specifically, refer to page 4 of the attached consent calendar --- Two proposed new courses (NURS 6400 and NURS 6991), one change in credit hours and six changes in course titles were received from the Nursing Department on July 13, 2007 which was one day after the posted cut-off date for items to be included on the consent calendar. The sub-committee had met on July 24, 2007 without any such curriculum changes from Nursing included on the consent calendar that was presented to them. The sub-committee did not have an opportunity to review the material as it was just now presented to them at this council meeting. Since this was an unfair burden placed on the sub-committee, the proposed changes in credit hours and course titles with effective dates of Spring 2008 and Fall 2008 would be tabled until the next sub-committee meeting in September 2007. Dr. Staples recommended that the sub-committee convene immediately to review the two proposed new courses (NURS 6400 and NURS 6991) as their effective dates are Fall 2007.

The motion was made to accept review and approval of the two above mentioned proposed courses by the assigned sub-committee. The motion was seconded and carried.

Upon review, the proposals for NURS 6400 and NURS 6991 did not meet the standards of the Council. Dr. Staples will notify the Director of the School of Nursing of the required standards.

Including afore mentioned amendments to page 4 of the consent calendar, a motion was made to accept the consent calendar as such. The motion was seconded and carried.
