A. Grad Faculty- Program Directors – Dr. Racha El Kadiri

Dr. Racha El Kadiri introduced the topic of whether program directors should be required to hold Graduate Faculty Status.

Dr. Helen Binkley expressed support, noting that this is the purpose of the various categories of Graduate Faculty Status, with Teaching Status being the appropriate option for program directors.

Dr. Salter opposed, stating that program directors should be required to hold Full Graduate Faculty Status, arguing that the current requirements are already minimal compared to other universities.

Dr. Carol Nies suggested that program directors should hold Graduate Faculty Status, but not necessarily at the Full level, as it may depend on the program.

Dr. Alyson Lischka added that consideration should be given to the nature of each program when determining requirements.

Dr. Kate Pantelides stated that program directors should hold Graduate Faculty Status, while recognizing that different skills may be required depending on the role.

Dr. El Kadiri emphasized that some programs are more professional in nature rather than research-based, and that the different levels of Graduate Faculty Status allow for needed flexibility.

Dr. Morrell clarified that Graduate Faculty Status for program directors should be limited to Teaching or Full, not Adjunct.

Following discussion, Dr. Helen Binkley moved that all program directors be required to hold Graduate Faculty Status, either Teaching or Full. The motion carried with 15 votes in favor and 3 votes opposed.

Dr. El Kadiri inquired when this requirement would take effect. It was established that the requirement will go into effect beginning Fall 2026.

IV. Announcements:

Dr. Lambert noted that he has a scheduled meeting with Dr. El Kadiri to discuss the Appeal process. This item will be brought forward for discussion at the October meeting.
