Note: Admission to the BS Athletic Training is closed to new students. This disclosure applies to current students until the program teach-out ends in Summer 2027. Prospective students interested in a career as an athletic trainer are encouraged to apply to the [Master of Science \(MS\) in Athletic Training](#) program.

Pursuant to 34 CFR [§668.43](#), Middle Tennessee State University (MTSU) provides the following disclosure related to the educational requirements for professional licensure and certification necessary for employment in Tennessee.

The Bachelor of Science in Athletic Training (BS Athletic Training) in the College of Behavioral and Health Sciences is accredited by the Commission on Accreditation of Athletic Training Education (CAATE). Admission to the BS Athletic Training does not guarantee that students will pass the Board of Certification Exam (BOC Exam) or obtain an athletic trainer license. The educational requirements for licensure as an athletic trainer in Tennessee include an earned degree from an athletic training program accredited by CAATE and a successful result (designation of "pass") on the BOC Exam. Successful program completion meets the educational requirements and qualifies students to sit for the BOC Exam and apply for licensure in Tennessee.

The table on page two of this disclosure indicates the states and territories where MTSU has determined, through reasonable, good faith effort, that the BS Athletic Training does or does not meet the educational requirements to sit for the BOC Exam or obtain licensure as an athletic trainer. Licensing authorities for each state set and enforce their own requirements and standards, which are subject to change. State requirements may include additional and recurring requirements, such as an application, supervision, examinations, continuing education, fees, fingerprinting, a background check, etc. MTSU strongly recommends that current students not located in Tennessee or who plan to seek licensure or certification outside the state of Tennessee consult the [state regulation information](#) provided by the Board of Certification for the Athletic Trainer and contact the appropriate state licensing agency or board. Students should discuss their plans with an advisor to ensure they have the most up-to-date information and guidance regarding licensure requirements.
